All its production lines are equipped with highly-sophisticated electronic systems and stringent control procedures ensuring thorough supervision of the entire process.


Many of the products supplied by FNMT-RCM are indispensable for Spain's economic activity and the sound working of the State Administration.

The authenticity of these documents and the confidentiality of data are of the utmost importance and this is ensured by the security with which the productive processes themselves are carried out.

So as to prevent falsification, identification documents incorporate **state-of-the-art graphic security systems**: special paper with watermarks, luminescent fibres, security thread, iridescent printing, intaglio, optically variable inks, laser engravings and so on. In addition, plastic security substrate ensure invalidation should the documents be tampered with.

At the present time, FNMT-RCM is responsible at the institutional level for the production of the following identification documents for Spain and other countries:
